
However, in June 2016, Amtrak, in collaboration with the FRA, made the decision to cease inclusion of the ABGT in concepts developed for the SEP going forward. After a thorough and complete analysis of future rail operations and service plans and rigorous coordination with other future rail planning initiatives, Amtrak, in collaboration with FRA, determined the future projected rail capacity at Washington Union Station could be accommodated within the proposed track alignments in a manner that is consistent with both the NECF and other future operating plans. These findings and proposed track alignments will be detailed further in the Terminal Infrastructure report.


