

T.O. 1 NORTHEAST

The Northeast has had thirty-one projects funded under the HSIPR and TIGER Programs to date; a federal investment of \$700 million. To date, six of these projects have been completed.

Projects within the region range from planning to construction; improvements to existing stations to building new stations; rehabbing existing track to installing double track; grade crossing improvements to new signal systems:

- PE/NEPA − 4
- FD/Construction 20
- Corridor Programs 3



An effective passenger rail network is critical for such a densely populated region.
