## **CULTURAL RESOURCES REPORTS**

As part of the Washington, D.C. to Richmond Southeast High Speed Rail (DC2RVA) Project, Dovetail Cultural Resource Group (Dovetail), on behalf of the Virginia Department of Rail and Public Transportation (DRPT), conducted reconnaissance-level architectural surveys of each of the 22 segments¹ comprising the DC2RVA corridor, as well as a reconnaissance-level architectural survey of all structures over 48 years of age in the full 123-mile corridor. DRPT also conducted a Phase IB archaeological survey of the 20 main line segments (Rosslyn to Alexandria [ROAF] through Buckingham Branch/Hospital Wye [BBHW]) of the DC2RVA corridor.

Dovetail submitted cultural resources reports that document these surveys to the State Historic Preservation Office (SHPO) for review and approval (Table R-1). Copies of these reports are included in this appendix.
