If the goal of the CHSRA 60 day review period is to eliminate quality public and local government participation in this project, then 60 days is a reasonable amount of time; however, if the goal is to accumulate intelligent and thorough comment and debate, then an extension of six

I am certain that you are aware that precedent was established in 2004 regarding this issue when the CHSRA used a 6-1/2 month EIR/S period of review for this same project. The 2004 EIR/S was not as complex or as detailed as the current DEIR/S, so logic would dictate that the current DEIR/S report, with its in-depth detail, should receive at least the same level of consideration by the public and affected local governments.

In the spirit of the California Environmental Quality Act (CEQA) and the National Environmental Protection Act (NEPA), by which this process is bound, we join with many other groups and individuals in asking for your immediate action in regard to this request.

The purpose of this letter is to request mitigation from the California High Speed Rail Authority for the noise and vibrations that will impact the Hotel (4241 Chester Lane, Bakersfield, CA 93309, APN# 332322130).

According to the Draft EIR/EIS the Hotel will be affected both by noise and vibrations due to the close proximity of the proposed High Speed Rail routes.

The Hotel is an extended stay hotel that accommodates guests for an extended period of time. Guests include those that are in town on business or leisure for one night or longer, typically thirty (30) days or longer. Guests see this hotel as a representation of Bakersfield as this is their home away from home, during a special project or relocation to

One of the primary responsibilities of a hotel is to provide a peacefully nights sleep. With the addition of the High Speed Rail there will be the added noise and vibrations when the trains go by the property. We believe that this will negatively affect the guest's experience and may cause them not to return to the Hotel, which would negatively affect the

The Hotel is asking for noise and vibration mitigation to be included in the High Speed Rail scope of work. The Hotel would be agreeable to the mitigation on and around the rail or funding allotted to upgrading the

The potential noise impact has been assessed at sensitive receivers, and these areas are identified in Section 3.4.5, Environmental Consequences, of the Revised DEIR/Supplemental DEIS and shown in Figures 3.4-9 through 3.4-13. The locations of potential barriers are illustrated on Figures 3.4-15 through 3.4-19. Refer to Section 3.4.7 for a complete listing of noise impact mitigation measures that would reduce noise impacts below a "severe" level. The Proposed California High-Speed Train Project Noise and Vibration Mitigation Guidelines developed by the Authority (see Appendix 3.4-A of the Revised DEIR/Supplemental DEIS) were used to determine whether mitigation would be proposed for these areas of potential impact. The Guidelines require consideration of feasible and effective mitigation for severe noise impacts (impacts where a significant percentage of people would be highly annoyed by the HST project's noise).

The Authority will refine mitigation for homes with residual severe noise impacts (i.e., severe impacts that remain notwithstanding noise barriers) and address them on a case-by-case basis during final design of the Preferred Alternative. In addition to the potential use of noise barriers, other forms of noise mitigation may include improvements to the home itself that will reduce the levels by at least 5 A-weighted decibels (dBA), such as adding acoustically treated windows, extra insulation, and mechanical ventilation as detailed in Section 3.4.7, Project.

The Revised DEIR/Supplemental DEIS proposes noise barriers in areas of severe noise impacts resulting from the project, where the barriers meet the cost-effectiveness criteria. To meet the cost-effectiveness criteria, barriers must mitigate noise for more than 10 sensitive receivers, be not less than 800 feet in length, be less than 14 feet in height, and cost below \$45,000 per benefited receiver. A receiver that receives at least a 5-dBA noise reduction due to the barrier is considered a benefited receiver.

Mitigation Measure N&V-MM#3 provides that sound barriers may be installed to reduce noise to acceptable levels at adjoining properties. These may include walls, berms, or a combination of walls and berms. The specific type of barrier will be selected during final design, and before operations begin. In addition, Mitigation Measure N&V-MM#3 provides that prior to operation, the Authority will work with communities regarding the height and design of sound barriers, using jointly developed performance criteria, when

the vertical and horizontal location have been finalized as part of the final design of the project. Mitigation Measure VQ-MM#6 requires the provision of a range of options to reduce the visual impact of the sound barriers. Noise and vibration generated by project operations has been analyzed at the hotel. The vibration impact assessment is primarily designed to identify the potential human annoyance from vibration from HST operations for buildings with vibration-sensitive use as described by the FRA and Federal Transit Administration land use categories. However, all buildings in close proximity to the proposed alignments were assessed for potential structural damage from HST operations and/or construction. The potential for damage from vibration from HST operations is limited to extremely fragile building locations within 30 feet of the tracks. The HST right-of-way width varies from 120 feet for at-grade tracks to approximately 60 feet for elevated fill to approximately 45 feet for elevated structures. In general, the area of impact is therefore within or close to the project right-of-way. Typical buildings, such as residences, located outside this distance would not have the potential for damage from vibration.

Agricultural resources, such as crops, would not be affected by noise and vibration from HSTs. As described in EIR/EIS Section 3.4.3, locations with potential vibration impacts in the project corridor are because of the potential for annoyance effects from HST operations. While the vibration at these locations might be felt by receivers, it would be well below the thresholds for damage to structures. It is helpful to note that the vibration levels generated by passing HSTs would generally be less than the levels generated by freight trains in the study area.

There will be no severe impacts at the hotel, and no additional mitigation is necessary.
