Dear Chairman and Members of the Board:

The Riverdale Public Utility District is located in south east Fresno County near the northern border of Kings County. The area is a thoroughly developed agricultural region with dense local and on-farm water infrastructure to support the dense agricultural development that has come into being over the last 130 years. The District Board of Directors and its staff has attempted in good faith to review the above DEIR/S. The document, however, is massive and consists of at least 17,000 pages when all its technical appendices are included. For many months prior to release of the DEIR/S the Authority provided little to no project details or answers. The typical pattern of the Authority's representatives was to decline to answer specific questions, but instead to refer effected parties and the public to await the release of the Project DEIR/S as all the answers would be provided in that document. The Authority and its representatives have not been forthcoming with project specific information or a specific proposal that is not subject to change throughout various meetings prior to the public release of the DEIR/S.

Our preliminary review indicates that the DEIR/S is not in compliance with State and Federal law and provisions established to protect to public and the environment. In addition, the Authority has failed to make available to the public all documents referenced in the DEIR/S. Due to the unwillingness of the Authority to provide timely and relevant project information, the District as well as other impacted parties of interest have had to simply rely upon reviewing the 17,000 pages of environmental documents to try to gain a clear understanding of this project proposal and means by which the Authority will mitigate potential impacts in Fresno and Kings County. review time of 45 days to consider all 17,000 pages* of the technical documents was extended by Authority staff an additional token 15 days.

However, this total 60 day time frame is a totally inadequate amount of time for the District and the public to conduct a thorough, meaningful review of the DEIR/S. Simply to read 17,000 pages in 60 days means reading the equivalent of reading a 280 page book every day for 60 days, and simultaneously be able to produce a meaningful critique of all that was read. These numbers show the absurdity of the 60 days review period offered by the Authority. In fact, the 60 day review period is meaningless and makes a mockery of the public education, public participation and due process goals of CEQA.

Clearly it is physically impossible for anyone to read the DEIR/S in the current 60 day review period, especially if that person must rely upon a paper copy available at the public libraries due to the library's limited hours of operation.

Therefore, in the public's interest, the District most strongly requests that the Fresno to Bakersfield Section EIR/EIS comment review period be extended to a minimum of six (6) months, through mid February 2012, to ensure that an adequate period of time is provided to the District and the public so that the public trust is upheld in protecting the public health, safety and welfare and the environment. Similar requests have been made by the California Farm Bureau Federation, the County of Kings other local land owners and communities that will be impacted, and the District hereby reinforces the need for and adequate DEIR/S comment review time as required by CEQA, the CEQA Guidelines, and by due process requirements.

As discussed in FB-Response-GENERAL-07, technical reports were prepared to record additional details on the environmental setting, impact assessment methodology, and environmental impacts for the following environmental disciplines: transportation, air quality, noise and vibration, biological resources and wetlands, geology, hazardous wastes, community impacts, relocations, aesthetics and visual resources, and cultural resources. Preparation of technical reports is not required by CEQA or NEPA. CEQA and NEPA do not require that these reports be distributed for public review with an EIR/EIS. However, all of the technical reports except the reports on cultural resources were posted on the Authority's website for public review at the same time as the Draft EIR/EIS and the Revised DEIR/Supplemental DEIS. The availability of these technical reports was included in the notices to agencies, elected officials, Native American tribes, organizations, individuals on the project's mailing list, and owners of land adjoining and near the alternative alignments.

The technical reports for cultural resources were not made available to the general public to protect those resources. Specific locations of wetlands and known populations of threatened and endangered species were also redacted from the biological resources and wetlands technical reports made available to the general public to protect those resources (e.g., Authority and FRA 2012f). The Authority and FRA provided the cultural resources technical reports and redacted biological and wetlands information to experts in the fields of historic architecture, archaeology, and biology on their request.

One that was set up to meet all of our needs, from the layout of the house which would accommodate my business when the time was right, to the 3 stall horse barn and hay storage area out back and the large section of the back property that has eenee been turned into a lighted arena for my 4-H girls to ride and practice in, and the cross fencing to accommodate the children in the dayoare and separate them from the animals out back. We found our home and we put everything into it to make it perfect for us and my goals for the business.

- · We landscaped the front yard and put an iron fence around the front.
- We put in an automatic security gate at the driveway entrance to make the property saver.
- We put in a lighted arena and added three more pens with covers for the horses,
- And like a lot of my neighbors invested our nest egg into our home, business and future

Then I quit a job that I had been at for 18 years to own and operate my own business. We had finally got to where we believed we should be at this point in our life and now because of some State wide project and an incomplete Environmental Impact Report we stand to loose it all, our home and to relocate a business that will have downtime due to getting relicensed at a new location. And then will I be able to find all of the amenities that my property has and still be in an area that will work for my parents and children or will I be starting all over with my business. Here I feel like I have so much to offer the children in my care from a safe and fun environment to a little bit of country where they can learn and grow.

So yes I am opposed to the current routes being considered not only personally but from the stand point of the other citizens of Bakersfield who also have a lot to loose. It is not in the best interest of a City to disrupt this many home owners, businesses, churches and schools in a community when an alternate route would be less evasive to the community. I would be willing to drive the extra twenty minutes to a train station to help maintain my City more of the way it is now not with a high-speed train running through it.
